

## **Official Rules and Regulations**

### **Raffle**

Camelot Therapeutic Horsemanship (CAMELOT), a tax exempt organization under Section 501(c)(3) of the Internal Revenue Code, is conducting this raffle to raise funds for ongoing program purposes. The Rules and Regulations of the CAMELOT raffle are set forth below. By purchasing a raffle ticket the purchaser agrees to be bound by these rules and regulations. CAMELOT's interpretation and application of the rules and regulations shall be final. The drawing for CAMELOT will be held on Saturday, April 22, 2017 at the Hooves & Heroes annual fundraiser. The winner does not need to be present to win. The chances of winning are based on the number sold. The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions. The winner of the raffle assumes all fees, including sales tax, license and documentation fees.

BY ENTERING THIS RAFFLE, ENTRANTS ACCEPT AND AGREE (1) TO BE BOUND BY ALL THE RULES, LIMITATIONS AND RESTRICTIONS SET FORTH HERE AND (2) THAT THEIR NAMES AND/OR LIKENESSES MAY BE DISCLOSED TO AND USED BY THE NEWS MEDIA AND MAY OTHERWISE BE USED BY CAMELOT FOR PUBLICITY PURPOSES AND IN LISTS OF PRIZE WINNERS TO BE PUBLISHED IN AREA NEWSPAPERS AND ANNOUNCED ON THE CAMELOT WEBSITE. BY ENTERING THIS RAFFLE, EACH PARTICIPANT RELEASES CAMELOT, ITS DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS FROM ANY AND ALL LIABILITY FOR INJURIES, LOSSES OR DAMAGES OF ANY KIND CAUSED BY PARTICIPATING IN THE RAFFLE OR WINNING ANY PRIZE OR RESULTING FROM ACCEPTANCE, POSSESSION, USE OR MISUSE OF ANY PRIZE, AND EACH WINNER AGREES TO INDEMNIFY AND HOLD CAMELOT HARMLESS FROM ANY AND ALL LOSSES, DAMAGES, RIGHTS, CLAIMS AND ACTIONS OF ANY KIND ARISING IN CONNECTION WITH OR AS A RESULT OF PARTICIPATING IN THE RAFFLE OR THE WINNER'S ACCEPTANCE OR USE OF ANY PRIZE.

### **Tickets:**

Tickets are \$10.00 each or six (6) for \$50. Only one eligible person may be entered in the raffle per ticket sold. If the name of more than one person is submitted with a ticket purchase, and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Division of prize by a group purchasing a ticket in common shall be the sole responsibility of the person named as the holder of record of that ticket, should that ticket be selected as a winner. CAMELOT reserves the right to reject any entry form that is submitted with payment that does not constitute "good funds."

A RAFFLE PARTICIPANT'S SOLE AND EXCLUSIVE REMEDY SHALL BE LIMITED TO THE RETURN OF THE PURCHASE PRICE PAID FOR HIS OR HER RAFFLE TICKET(S). IN NO EVENT SHALL CAMELOT, ITS DIRECTORS, OFFICERS, EMPLOYEES, AGENTS OR REPRESENTATIVES BE LIABLE TO ANY PARTY FOR ANY LOSS OR INJURIES TO EARNINGS, PROFITS OR GOODWILL, OR FOR ANY INCIDENTAL, SPECIAL, PUNITIVE OR CONSEQUENTIAL DAMAGES OF ANY PERSON OR ENTITY WHETHER ARISING IN CONTRACT, TORT OR OTHERWISE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

### **How to Purchase:**

### **Selection of Winners:**

The CAMELOT raffle drawing will be held on April 22, 2017, between 3PM and 4PM PST from all eligible raffle tickets received. Winners need not be present to win. Winners will be notified by phone, email or U.S. Mail according to the contact information provided to CAMELOT at the time of ticket purchase. If any winner cannot be located by 5:00 p.m., April 30, 2017, after attempting to make contact through the information provided at the time of purchasing the ticket, such winner will be deemed to have forfeited his or her prize and another winner will be selected for such prize. In order to collect his or her prize, a ticket winner must sign and deliver to CAMELOT the winning ticket stub along with proof of identity.

### **Winning Odds:**

The odds of winning a prize will depend on the number of tickets sold.

### **Eligibility:**

Anyone 21 years of age or older may enter. Employees and members of the Board of Directors of CAMELOT are excluded from participating and are not eligible to win the prize. All federal, state, and local laws and regulations apply. The raffle is void where prohibited or restricted by law. An affidavit of eligibility may be required from prize winners.

Any controversy or claim arising out of or relating to the contract, or the breach thereof, shall be settled by binding arbitration determined by an Arbitrator selected by agreement of CAMELOT and the Claimant, or in the event of failure of agreement pursuant to the expedited procedures of the American Arbitration Association under its Commercial Arbitration Rules, and judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof.
